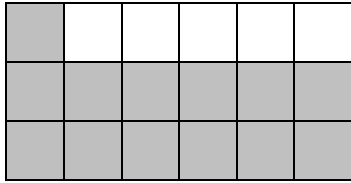

Rules for Signed Numbers

<i>Addition</i>				<i>Subtraction</i>			
Positive	+	Positive	= Positive	$A - B = A + (-B)$			
<b>POSITIVE</b>	+	Negative	= Positive				
Positive	+	<b>NEGATIVE</b>	= Negative				
Negative	+	Negative	= Negative				
Numbers in bold, capital letters have a greater magnitude than nonbold, lower case partner number.							
<i>Multiplication</i>				<i>Division</i>			
Positive	×	Positive	= Positive	Positive	÷	Positive	= Positive
Positive	×	Negative	= Negative	Positive	÷	Negative	= Negative
Negative	×	Positive	= Negative	Negative	÷	Positive	= Negative
Negative	×	Negative	= Positive	Negative	÷	Negative	= Positive

Examples of Operations with Decimals

$1.2 + 3.45 =$

$1.2 \times 3.45 =$

$3.4 \div 1.2 =$

$$\begin{array}{r} 1.2 \\ + 3.45 \\ \hline 4.65 \end{array}$$

$$\begin{array}{r} 1.2 \\ \times 3.45 \\ \hline 60 \\ 480 \\ 3600 \\ \hline 4.140 \end{array}$$

Rules for Fractions

For any real numbers,  $a, b, c,$  and  $d, b \neq 0, c \neq 0,$  and  $d \neq 0$

$$\frac{a}{c} + \frac{b}{c} = \frac{a+b}{c}$$

$$\frac{a}{c} - \frac{b}{c} = \frac{a-b}{c}$$

$$\frac{a}{b} \cdot \frac{c}{d} = \frac{ac}{bd}$$

$$\frac{a}{b} \div \frac{c}{d} = \frac{a}{b} \cdot \frac{d}{c} = \frac{ad}{bc}$$
